- 4. Paribartan aims at empowering women through community based organizations, the process of establishing a self-supportive federation and withdrawal, handing over responsibility to the federation.
- 5. Paribartan visualizes itself to emerge as a Resource Centre based on Adivasi way of life in the area of Natural Resource Management, sustainable agriculture (dry land farming, organic farming), community based and led health care management and Advocacy initiatives.

ACTIVITIES ON ADIVASI DEVELOPMENT, THEIR FOREST LIFE AND LIVELIHOOD:

#### Implementation of FRA 2006

Since 2007 Paribartan initiated the facilitation process for recognition of rights for Adivasi over customarily used forest recorded lands in Pallahara. Hundreds of individual claims of Adivasi households over forest recorded land are filed with support of Paribartan volunteers .Paribartan has been empowering community to file claim, follow up with concern authorities, and after all enabling community for asserting their legal rights over customarily used forest recorded land and community forest resources. To ensure Adivasi and other forest dwellers to assert their claim and rights over their customarily used forest lands, Paribartan has given thrust for enabling community and empowering them.

Capacity Building training to the key representatives on Planning and Management of Land given under FRA- 2006

Tribal families were awarded land (IFR). It was critically assessed that the tribal community possess Land Patta under FRA 2006, needs hand holding support that to say proper long term planning is essential for judicious and productive utilization of the land without affecting the ecological benefit that the land provides. Sustainable forest management is key to the sustainable livelihood. There has to be a harmonious balance between conservation of forests and development of communities through livelihood security. It is clear that forest productivity will ensure equity and livelihood for the tribal community. Series of awareness meetings have been organized in each village of the operational area before implementation of the programme.

## **Agricultural Activities for Food security**

Paribartan's major concern is to enhance the food and livelihood security of the resource poor through environment friendly, economically appropriate, socially just farm and non farm activities furthering sustainable development

through empowerment of resource poor and establishment of community-controlled biodiversity based Food Production system. Paribartan took up 65 agriculture focussed activities with tribal communities. These included land bunding, community farming, making of kitchen gardens and irrigation related activities which result in more efficiency and better productivity for the farmers of the targeted villages. It continuously striving towards bottom up livelihood planning, aggregation of community livelihood needs physical and financial plan at Panchayat level, holistic coverage of sectors based on value chain requirements.

### Advocacy

Advocacy is creating space for dialogue between media policy makers and community on issues. Paribartan has taken facilitator's role in framing issues, bringing together constituencies, and monitoring commitments to ensure and defend the rights of the isolated community. The organization also aims to influence public opinion on development issues. Paribartan documents grassroots realities through field-based action /Piloting project in collaboration with groups, stakeholder's involvement and donor partners. This also includes developing and designing communication strategies for specific programmes and issues. Paribartan brings out information booklets on rights to water, rights to common resources with design and development of fliers, kits for demystifying media imagery, besides undertakes. *Policy advocacy by building alliances with CSO, Media and international community* through issue-based dialogues, debates and interaction with the mass media. At the same time capacitate community especially women through training and application of tool and techniques for sustaining the process by themselves.

#### Nursery raising & Vegetation with bamboo sapling and fruits bearing plants

The major objective of nursery rising activities has aimed at obtaining quality seedling. Paribartan facilitates tribal community participation for nursery rising activities with planting materials. The purpose of this activity is to foster community participation for protection conservation and regeneration of natural forest. It is planned to vegetate the fallow forest land with useful fruits bearing, oil seeds borne trees. Paribartan in close partnership with community initiated nursery raising activities .Tribal and forest dependant community initiated plantation work at fallow forest land with local plant species and doing patrolling. Conservation of medicinal plant species both in-situ and ex-situ is another dimension of the project result.

## Community Grainage & Disease Free Laying production and Tasar Rearing

Indigenous knowledge, ancestral property, rich culture & traditions are the major contributing factors for secure livelihood of tribal community. Farm forestry, specifically wild Tassar rearing, seems to be the most appropriate and feasible activity for the economic empowerment of tribal community. Paribartan started the Disease Free Laying production activities, now it becomes a continuous programme and Paribartan has been emerged at a resource center in farm forestry sector in particular for production of DFLs. DFL production work was started during August 2006 at community level with technical support of Central Silk Board and successfully revitalized the eroded indigenous farm forestry activities of tribal community.

Alliance Strengthening and Collective action.

Paribartan is engaged with Civil Society Organizations and alliances to collectively struggle for the rights and entitlements of the tribal and forest dependant community .Paribartan participated in state, regional and international arena and shared the real field level happenings with other actors of development to add power to the voices of the voiceless .Paribartan the team members and representatives of tribal community participated in NAA activities and exchanged their views and thoughts on to ensure the rights and entitlements of tribal and forest dependant communities.
